ORDER:

In the 30th Board Meeting held on 2nd February' 2018, it has been decided to sanction of one Special Increment to all the employees of TSGENCO, in the form of Special Pay with effect from 01-01-2018, which will not count for DA and Pensionary benefits etc., in token of appreciation for the dedicated services rendered by them in providing round the clock power supply to the Agriculture Sector and also keeping in view of the announcement made by the Hon'ble Chief Minister of the State.

2. Accordingly, TSGENCO hereby issues the following orders for sanction of Special Increment to the employees of TSGENCO with effect from 01.01.2018.

- (i) The Special Increment shall be sanctioned to all the employees of TSGENCO in the form of special pay equivalent to the immediate previous increment drawn in their current pay scale as on 1-1-2018 (like FPI, Telangana Increment).
- (ii) The Special Increment equivalent to the first increment to be drawn in their current pay scale shall be sanctioned to the employees who are newly recruited and joined on or before 01.01.2018 and who have not completed prescribed period of service for sanction of Annual Grade Increment.
- (iii) The Special Increment equivalent to the first increment to be drawn in their current pay scale shall be sanctioned to those employees who are appointed in higher pay scale under Automatic Advancement Scheme and has not drawn increment in the SGP/SPP-IA/SAPP-IA/SPP-IB/SAPP-IE/SPP II/SAPP-II scale of pay.
- (iv) The Special Increment shall be shown in the Pay Bill separately and distinctly as a special pay.
- (v) The Special Increment shall be permanently fixed amount separately attached to the pay during the entire period of service and shall not reckoned for the purposes of fixation of pay on promotion or otherwise in future.
- (vi) No allowance such as DA, HRA, CCA or any other allowance shall be admissible on the Special Increment.
- (vii) The Special Increment shall not be taken into account for the purpose of fixation of pension and pensionary benefits such as Gratuity and Commutation of Pension.
- (viii) The Special Increment shall be payable starting with the salary for the month of January'2018.
- (ix) The Special Increment will not count for surrender leave.
