Under Regulation 14(a)(1) of APSEB Service Regulations Part-II, as adopted, 09 (Nine) Sub-Engineers (Civil) mentioned in the Annexure appended to this order are appointed by transfer purely on temporary basis as Addl. Asst. Engineers (Civil) with effect from the date of their actual joining duty in the scale of pay of Rs. 39455-1700-44555-1985-54480-2280-61320 with usual allowances admissible from time to time. They are posted as Addl. Asst. Engineers (Civil) to the places noted against their names in the Annexure appended to this order. The seniority of the above Sub-Engineers in the cadre of AAE will be fixed separately.

2) Their appointments as ordered above shall be subject to the following conditions, namely:-

- i) The appointments ordered above are purely temporary and do not confer any right to regular appointment as Addl. Asst. Engineers (Civil).
- ii) The temporary appointments ordered above are liable for termination at any time without notice and without assigning any reasons therefor.
- iii) The appointments ordered above are subject to production of physical fitness certificate issued by a Medical Officer of a rank not less than that of a Civil Surgeon at the time of joining as Addl. Asst. Engineer (Civil).
- iv) The candidate shall have to pass the prescribed tests as per APSEB Service Regulations as adopted.
- v) The seniority of the Addl. Asst. Engineer (Civil) now appointed and the Addl. Asst. Engineer (Civil) who may be appointed in the subsequent batches, if any, will be determined by TSGENCO separately.
- vi) The candidate shall join duty within 15 days from the date of their relief.
- vii) The candidates are informed that if they do not report as Addl. Asst. Engineer (Civil) within 15 days duly obtaining proper relief, the orders of their appointment by transfer as Addl. Asst. Engineer (Civil) will be cancelled without further notice.


